Summary

The Financial Analyst performs analysis of actual operating and financial data. In addition, this individual will support budgeting and forecasting process; perform cash management and finance activities which include actuals versus budget analysis, long-term and short-term cash flow forecasting, Accounting and Financial Planning systems integration and implementation, process improvement, cash management, and allocation of shared services across company's platform.

Key Job Responsibilities

- Perform in-depth analysis of actual financial performance to provide feedback to management, determine value drivers, and explain discrepancies from targeted performance
- Assist in the development and maintenance of the company's corporate model by working with multiple teams within the organization to ensure dependencies are reflected and projects updates are incorporated
- Support implementation of planned organizational structure within the accounting and financial planning system to ensure accurate representation of the business lines and investor ownership across different platforms
- Participate in the preparation of annual budgets and quarterly forecasting process
- Assists with cash management, including preparation and maintenance of 13 weeks cashflow model
- Engage in preparation and maintenance of Shared Services Allocation Key to ensure shared costs are accurately allocated to respective entities and projects within the company's organization structure
- Prepare insightful analysis using data analytics tools to help management report on various project milestones and operating business performance to internal and external stakeholders
- Assists in preparation of company dashboard reports, presentations, and policies related to finance and treasury activities
- Collaborate with operating entities to ensure accurate financial reporting of various project activities
- Support the treasury function to ensure internal and project financing objectives are met
- Identifies opportunities for performance improvement across the company's platform for long-term sustainable operations
